Mayor Houston opened the Public Hearing and John Taylor reported that the Planning and Zoning Commission recommended approval on April 17, 2012; however, different amendment options to the ordinance have been discussed since that time. Staff recommended remanding the item back to the Planning and Zoning Commission for further discussion at its October 15 meeting, and bringing the item back to City Council on October 23. Mayor pro tem Frizzell moved to continue the Public Hearing until October 23 and to remand the item back to the Planning and Zoning Commission for further consideration. Motion was seconded by Councilmember Kyle and carried unanimously (7-0).

John Taylor presented the Item, explaining the joint public hearing is part of a May 2012 settlement agreement between the City, Randy Denton and MidTexas International. Also, as part of the settlement agreement terms, the City agreed to waive fees for zoning and platting application, pending formal Council approval. Mayor pro tem Frizzell moved to call for a Public Hearing on October 9, 2012 and to approve the waiver of applicable zoning and platting fees. Motion was seconded by Councilmember Kyle and carried unanimously (7-0).

2012-362 CONSIDER AND ACT UPON A LICENSE AGREEMENT WITH THE CITY OF WAXAHACHIE, TEXAS, THAT WILL PERMIT THE CITY OF MIDLOTHIAN TO UTILIZE THE CITY OF WAXAHACHIE'S NEWEST ELEVATED WATER TOWER AT 528 SUITE A, OVILLA ROAD, WAXAHACHIE, TEXAS, FOR A REMOTE RECEIVING SITE AS PART OF THE NEED CENTER UPGRADED COMMUNICATIONS INFRASTRUCTURE

Chief Schrodt explained the need for a remote receiver site in the southeastern portion of the City and the Emergency Services District. The City of Waxahachie is willing to allow the City of Midlothian to use their newest elevated water tower for the remote receiver at no charge. Councilmember Kyle moved to approve execution of the License Agreement with the City of Waxahachie and to authorize the Mayor to execute same. Motion was seconded by Councilmember Sibley and carried unanimously (7-0).
