2014-215 CONSIDER AND ACT UPON AN ORDINANCE AMENDING THE CODE OF ORDINANCES BY AMENDING CHAPTER 3 "BUILDING REGULATIONS" BY ADDING SECTION 3.03.033 "AMENDMENTS TO THE 1997 UNIFORM HOUSING CODE" TO ADOPT LOCAL AMENDMENTS TO THE 1997 EDITION OF THE UNIFORM HOUSING CODE; PROVIDING A REPEALING CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY OF FINE NOT TO EXCEED THE SUM OF TWO THOUSAND DOLLARS (\$2,000.00) FOR EACH OFFENSE; AND PROVIDING FOR AN EFFECTIVE DATE

2014-216 CONSIDER AND ACT UPON ORDINANCE AMENDING THE CODE OF ORDINANCES BY AMENDING CHAPTER 3 "BUILDING REGULATIONS" BY AMENDING SECTION 3.08.001 "ADOPTION OF CODE" FOR THE PURPOSE OF ADOPTING THE 1997 EDITION OF THE UNIFORM CODE FOR THE ABATEMENT OF DANGEROUS BUILDINGS; ADDING SECTION 3.08.003 "AMENDMENTS TO THE 1997 EDITION OF THE UNIFORM CODE FOR THE ABATEMENT \mathbf{OF} DANGEROUS BUILDINGS" TO ADOPT AMENDMENTS TO THE 1997 EDITION OF THE UNIFORM CODE FOR THE ABATEMENT OF DANGEROUS BUILDINGS, INCLUDING AMENDING SECTION 205.2 "MUNICIPAL COURT JURISDICTION REGARDING DANGEROUS BUILDING ORDERS" TO ESTABLISH A CIVIL HEARING PROCEDURE FOR THE MUNICIPAL COURT TO HOLD PUBLIC HEARINGS PURSUANT TO CHAPTER 54, SUBCHAPTER C, AND CHAPTER 214 OF THE LOCAL GOVERNMENT CODE FOR THE ENFORCEMENT OF HEALTH AND SAFETY ORDINANCES RELATED TO DANGEROUS BUILDINGS; PROVIDING A REPEALING CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE
