Defendant's Plea and Installment Agreement

I the above named Defendant do hereby enter my plea of Guilty/No Contest and waive my right to jury trial. I understand that I have a right to a jury trial and that my signature on this **plea of no contest** will have the same force and effect as a plea of guilty on the judgment of the Court. I understand that my plea may result in a conviction appearing on my criminal/driving record. Furthermore, I, the Defendant in the above numbered and entitled cause, do hereby acknowledge that I am hereby entering my plea and have not requested, and hereby waive any discovery pursuant Article 39.14 CCP. If any part of the fine/costs are paid on or after the 31st day after judgment, I am responsible for paying a time payment fee (Sec.133.103 LGC). If the Defendant is unable to make payment, contact the Court immediately. The Defendant is **ORDERED** to notify the Court of any change of address. Failure to comply with this order will result in a mandatory hearing and may cause the issuance of a capias pro fine. Art. 102.010 of the CCP requires a defendant to pay \$50 warrant fee for the execution of processing of an issued capias pro fine.

Defendant agrees to pay the fine/cost at designated intervals. The Court, **ORDERS** the Defendant to make payments as scheduled until the full amount is paid. **SCHEDULED PAYMENTS:** FIRST Payment of \$_____ is due **TODAY**. The **NEXT PAYMENT IS DUE 30 DAYS** from today until the total amount of is paid in full. A \$15.00 fee is added to each violation that is placed on a payment plan. Payment may be made online at www.midlothian.tx.us using a Visa or MC; Money Order or Cashier check can be mailed in at the above address. **PERSONAL CHECKS ARE NOT ACCEPTED!!!**

The Defendant acknowledges the receipt of a copy of this order and understands the provisions of this order and has the ability to fully comply with this order. Further, the Defendant understand his/her responsibility to inform the court of changes in his/her financial situation that may hinder his/her ability to satisfy either the judgment or any other order of the Court. The Defendant understands his/her responsibility terminates only upon satisfaction of the judgment.

ADMONISHMENT AS TO FINANCIAL CHARGES

All defendants unable to pay the entire fine and courts costs when sentenced, are required to carefully read and acknowledge the following:

I, the undersigned, acknowledge that until my fines and court costs are paid in full, I agree to notify the court of any changes to my personal financial situation that will likely interfere with my ability to pay the fine and court costs in the manner ordered by the Judge.

It is my responsibility to keep the court informed of my ability to pay the fine and court costs. It is my responsibility to keep the court informed in the event of financial hardship.

If you are assessed fines and court costs as a result of this citation and you are unable to pay, bring this to the attention of the judge. For more information, contact the court or an attorney.
